### BVI and Cottage Museum

You will notice on the agenda for the next General Meeting two items, numbered 6 and 7, relating to the future management of the BVI and the future direction of the Cottage Museum. Please consider the following before the meeting.

**The BVI Apartment** brings people to the building and contributes about \$7,000 net to the RDHS budget.

However the management time it consumes is not sustainable by our volunteers. So, the question is:

*Do we keep the apartment as a RDHS B&B or do we lease out the space?*

The following options, along with any others raised on the night, will be discussed...

- keep it as it is but pay for a higher level of service from an agent;
- keep it as it is and pay a manager to handle daily business;
- lease it out to someone else to run it as a B&B;
- lease out the space and no longer run a B&B.

**Cottage Museum** - After the successful restoration of the BVI and the Mural, the Committee is turning its attention to the sustainable operation of the Museum and recommends a working party think-tank, to report by June 2014, be established to plan the future development of our Museum.
